- 1] Your offer should be for a contractual period of one year from the date of commencement of services. Rates to be quoted as per format of Annexure 'I'.
- 2] Taxes / Service Tax, if applicable should be indicated clearly.
- 3] Successful tenderer is to submit a Security Deposit of Rs.5, 000/- which will be refunded without interest on completion of contractual period.
- 4] Detention charges for Matador, Tempo, Truck, Tractor are to be indicated in the offer separately.
- 5] Free time should be 6 (six) hours from the receipt of Challan by Stores.
- 6] Loading & Unloading Charges in case done by the transporter are to be quoted per MT basis. MINIMUM CHARGES FOR TRAILOR LOAD IS TO BE QUOTED.
- 7] Charges for transportation of off-size materials are to be quoted separately.
- 8] Incidental charges, if any, applicable during transportation shall be re-imbursed by HDPEL against documents.
- 9] HDPEL may require manpower for handling of materials. As such charges per man-day is to be indicated in the offer.
- 10] Govt. rules will be applicable for the services.
- 11] Contract shall be governed by the general terms and conditions of contract of HDPEL.
- 12] The vehicles to be deployed must have proper registration, insurance, certificate of fitment etc. required as per Govt. rule.
